Dear Owner(s):

The Board would like to report that the 2023 projects that include major landscape enhancements, new monument signs, new lighting, and painting of the community walls have been completed. Also, your management team has recommended, and the board has agreed that the annual assessment <u>will not</u> be increased in 2024. <u>This marks the ninth consecutive year without an assessment increase</u>. Finally, the board would like to hear what other enhancements you would like to see at Lakewood at the Crossings. Please email enhancements to <u>Lakewood@bonomgmt.com</u>.

Due to the date that our Association was originally founded, Lakewood at the Crossings Homeowners Association, Inc.'s (the "Association") governing documents need to be revitalized. This administrative process ensures that the Association is able to continue its critical role in protecting and preserving the property values within the community. This process requires the involvement of all members in the community to ensure compliance with Florida Law.

Our first mailing generated nearly 200 positive consents with only 3 non-consent responses. We need a total of 381 positive consents to revitalize the documents. To lower the expenses of the members of the community in performing this task, the Covenant Revitalization Committee for the Association is asking each member to consent to revitalize these covenants in writing. If we receive signatures from a majority of the members of the Association, we eliminate the need to hold an official meeting where homeowners would be required to attend in person.

Consequently, the Covenant Revitalization Committee for the Association needs every owner who currently appears on the deed of their property to date and sign the enclosed (blue), **Lakewood at the Crossings Homeowners Association, Inc Owner Approval, Joinder and Consent to Revitalized Declaration of Covenants, Conditions, and Restrictions for Units Two, Three, and Four.** A copy of the <u>unchanged</u> Revitalized Declaration as well as the Association's Articles of Incorporation and Bylaws are available on the LWATC.com website and the Owner's Portal at portal.bonomgmt.com for your review.

It is important that this is completed and returned to the Association within **thirty** (**30**) **days** of your receipt of this correspondence in order to avoid the need for an in-person meeting. Your response may be returned in the postage-paid return envelope or provided to a member of the Covenant Revitalization Committee.
